CHECK-IN and RELAY SELECTION for competitors: 7:00 to 8:20 AM Match Day
Rifles & Shooting Sticks must be weighed and measured at Check-In.

RANGE OPENS for PRACTICE 7:30 AM. The range will be closed the Friday immediately preceding the match for range preparation until noon or until setup is complete. Inclement weather may delay the opening

Line positions will be drawn 8:20 AM.

A **MANDATORY COMPETITOR'S MEETING** will be held at 8:40 AM. Match begins at 9:00 AM.

ELIGIBILITY: Competition is open to all, but the number of competitors is limited by the range capacity of 48 shooters. Only three relays will be run due to time considerations.

Pre-Registration is REQUIRED. We can almost guarantee you will not be able to shoot unless you have pre-registered. Shooters' slots will be held until 8:20 a.m. on match day, then forfeited and assigned chronologically to anyone on the pre-registration waiting list, then opened to non pre-registered shooters on a first come first served basis. Refunds will be made for cancellations made **prior to June 2nd**. *If you need to cancel please notify the match director ASAP so that shooters on the waiting list will have time to make plans. Each year last minute cancellations have kept others from being able to shoot.*

RULES: All current NRA Black Powder Silhouette rules will apply and any jury decisions will be final.

CLASSIFICATION: Current NRA Black Powder Silhouette classifications will be used.

AWARDS: Awards will be given for 1st & 2nd Match winners; 1st, 2nd & 3rd Class winners; High Senior, High Woman, and High Junior.

FOOD & BEVERAGES will be available in the clubhouse.
