While there they also went to each berm, at the 500, 400, 300 and 200 yd. Ranges and picked up all broken targets, hangers, and other garbage and disposed of it. Their targets were put in the garage with all the other targets.

Old business- Bob has sent an email to IB Able about installing more security cameras. He has not heard back from them.

An email was sent to all members about the use of range lights. It stated, Anytime your go down range the lights must be turned on. Even if the lights are already on, turn on the light switch at your shooting position. The shooter that turns on the switch must turn off the switch.

Six of the eight new lights have been installed for the trap range.

There was an alleged incident at the SFGA ranges on November 2nd. A member said unknown people were seen firing a shotgun at the pistol range back boards and behaving badly. Bob McClure was asked to provide a list of names of the club members on the premises between the hours of 1130 and 1330 on November 2nd.

A text message was sent to the club members present on November 2nd.

It stated-You were at SFGA on Sunday November 2nd between the hours of 1130 and 1330. An incident took place with people firing shotguns on the pistol ranges. The BOD is conducting an inquiry and the Chief Range Safety Officer is acting on their behalf.

Therefore he requires a statement from you on what you may have seen during this time. They were to reply by text or email to bring the matter to a speedy conclusion.

Several members did not reply to the email. There was one member who said he was there and shot his home security shotgun. He just wanted to shoot the gun because he had just bought it. He said he shot to the right of the backers at the bank. He shot two bird shot loads and one buckshot round. He then returned to his truck and no one mentioned or questioned him of confronted him at that time.

The member was advised that in the future he should use the shotgun station to the left of the pulley.

The Chief Range Safety Officer went to the range on November 3rd and inspected the Pistol ranges. The backer boards at the 50 25 yards were inspected. No damage attributable to shotguns was found.
